

50 MILE GARAGE SALE AT THE LOLO COMMUNITY CENTER

RULES AND IMPORTANT INFORMATION

12345 US Hwy 93 S. Lolo, MT 59847 * June 24 & 25, 2022 * Time: 8am - 4pm both days

1. **Vendor Access:** The sale area will be open and available at 6:30 am Friday morning and Saturday morning for set up. Please have your space ready for shoppers by 8am. All Vendors must vacate your booth(s) by 6pm on the last day of your booth rental.
2. **Booth Space:** 10x10 foot space. Tables, chairs, awnings/sales tent, change, and electricity are not available from the Lolo Community Center. Vendor must supply your own. If you choose to use an awning/sales tent, you need to provide sandbags/jugs filled with water/weights to tether it down. You may NOT stake/nail into the property. **You will be responsible for damage** caused by an unsafe or unsecure awning/sales tent. This would include damage to neighbors and/or their merchandise or customers. Awnings/sales tents must fit within the rented booth space. They may not extend out into the walking area or another vendors booth.
3. Whatever you bring in, you carry out. This includes all sale items you have brought in and any trash. Everything must be cleaned up by 6pm on the last day of your booth rental.

Vendors leaving the sale area or any center property in any condition requiring maintenance will be charged a fee no less than \$40 to be paid in full by June 30, 2022. You will also not be allowed to participate in this event in the future if this occurs.

4. This event is "open rain or shine". No refunds are granted.

5. Sale Area- unloading your vehicle of sale items:

*Please remove all vehicles from the sale area by 7:30 am and park in the back of the community center property (see map).

*No vehicles will be allowed back into the sale area to load large items.

*Any large items that are purchased will need to be hand carried or carted away.

*You also must stay until 4pm for each day you have booked. You may not leave early. Should you ignore this condition and damage the center property or grounds, you will be assessed those damages.

6. Vendors pets must be confined, always, in their booth space. All dogs **MUST** be on leashes, walked outside the sales area and cleaned up after **immediately**. Loud, threatening, or aggressive animals will not be tolerated.

7. Sellers are responsible for all family members and employees working in the assigned booth spot. Children must be accompanied by a parent/guardian always on the Lolo Community Center property.

. The following actions are banned from this event:

*Smoking/vaping

*Violent or abusive behavior (verbal or physical)

*Profanity

*Alcohol, drugs, or any other illegal substance

*Obscene materials or products

8. No selling of food or drinks without proper food permits from the Missoula County Health Department. Proof must be sent with the application and fee otherwise your booth will not be reserved.

9. The following products/services may not be sold at this event:

*Food unless with proper permits

*Candy and beverages unless with proper permits

*Animals (sold or given away)

*Alcohol, drugs, or illegal substances

*Paraphernalia

*Tattoos or body piercings

*Fireworks, ammunition, or dangerous items

*Pornographic material of any kind

10. Merchandise that violates copyright, trademark, or intellectual property is stolen, illegal or counterfeit is not to be sold at this event. Vendors are responsible for all products sold. Merchandise must be authentic, legal, licensed and not offensive to children and comply with all laws and government regulations.

11. Sellers will regulate the volume of radio's, TV's, stereos, and other equipment so as not to interfere with those occupying adjoining spaces.

12. No risk is assumed by the Lolo Community Center related to vendor vehicles, equipment, or merchandise parked or stored at the Lolo Community Center sale site located at 12345 US Hwy 93 S. Lolo, MT 59847. All vendors are encouraged to be fully insured for all possible event-related occurrences. There is NO SECURITY at this event.

13. Lolo Community Center will not be responsible or liable to seller for any loss or damage that may result to seller or his property or his property from water, fire, explosion, theft, willful or negligent act of the Lolo Community Center or its officers, agents, employees or from any other source or cause whatsoever.

14. We will have outdoor restrooms available for vendors and shoppers.

15. We will be providing a map of your booth location before the event via email and will also be available on our social media page Lolo Community Center on Facebook. Please join that for updates as we will also be creating an event link on there as well to share out.
