

## Vendor Rules and Regulations While on site at the Lolo Community Center Farmer's Market

WELCOME Farmer's Market Vendors! We're glad you are participating this year! Just a few necessities to go over.

- Vendor Access: Set up begins no earlier than 1pm on Fridays. You may park in the front of the Community Center to unload your vehicle and then you will need to move your vehicle to the South side of the building. Vehicles must be moved to the South side of the building no later than 1:45pm. After 6pm you may move your vehicle to the front of the Community Center for loading.
- Restrooms available for VENDORS ONLY in the Community Center. No public restroom access.
- Vendors will need to provide for their own needs. This may mean tables, chairs, canopy, appropriate signage, and other. The Community Center is not responsible for providing anything other than space.
- Vendors are responsible for any damages they may cause, so please use care and caution.
- Pack it in – Pack it out! This is a general courtesy rule. Please do not leave anything behind when you leave. If your area is found to have trash, or generally messy after you leave you may risk forfeiture of your space for future Farmer's Market dates. Your space must be cleaned and tidied no later than 7pm each Friday.
- Farmer's Market spaces will be 10'x10' outdoors, if inclement weather requires the vendors to move indoors, you will be required to, and responsible for, moving your own things.
- If the Market is moved indoors vendors will be responsible for any damages that may occur at a fee no less than \$40.
- If the Market is moved indoors vendors will be responsible for cleaning of their spaces. If you leave your sales area messy, sticky, dirty you will be charged a janitorial fee of no less than \$40.
- Vehicles are not allowed in the sales area. If you are a seller of larger items, those items will need to be hand carried to vehicles.
- Please do not plan to leave the event early.
- ABSOLUTELY NO Dogs/Pets area allowed. This is a health department regulation that as a food event we must uphold!
- ABSOLUTELY NO SMOKING or Vaping.
- No profanity
- No violent or abusive behavior (verbal or physical).
- ABSOLUTELY NO Alcohol, drugs, or other illegal substances.
- If you are a food vendor, you are required to know and follow any and all regulations regarding the sale of food. NO EXCEPTIONS.
- There will be no sales of: pornographic material, tattoos, piercings, drugs, alcohol, illegal substances, fireworks, ammunition, guns, dangerous items, or marijuana.
- Lolo Community Center will not be responsible or liable to any seller for any loss of damage that may result to seller or his/her property from water, fire, explosion, theft, willful or negligent act of the Lolo Community Center or its officers, agents, employees or from any other source or cause whatsoever.

Any failure to comply with these terms and conditions will result in permanent removal from the current Farmer's Market as well as subsequent Farmer's Markets. No refunds will be given for failure to comply removals.
